

## VOTING BY ABSENTEE BALLOT

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 10 consecutive days before the election. The elector must also be **REGISTERED** and provide proof of identification prior to receiving an absentee ballot.

### TO OBTAIN AN ABSENTEE BALLOT YOU MUST MAKE A REQUEST IN WRITING.

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the election. Your written request can be by mail, email or in person but must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature.

**Special absentee** voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk. **In-person absentee voting:** you can also personally go to the municipal clerk's office or other specified location, complete a written application, and vote an absentee ballot during the hours specified for casting an absentee ballot. Contact clerk for appointment.

The **FIRST** day to vote an absentee ballot in the municipal clerk's office is **upon receipt of ballots, or no later than January 29, 2018**. The **DEADLINE** for voting an absentee ballot in the clerk's office is **Sunday, February 18, 2018**, unless hours are posted above. Refer above for clerk's hours and contact information.

The **DEADLINE** for application to vote absentee by **Mail** is 5:00 p.m., on **Thursday, February 15, 2018**.

**No in-person absentee voting may occur on the day before the election.**

The municipal clerk will deliver voted ballots returned on or before Election Day to the proper polling place before the polls close on **Tuesday, February 20, 2018**. Any ballots received after the polls close at 8:00 p.m., will not be counted.
