

MEMORANDUM FOR: Adams County Highway Department

SUBJECT: Section 404 Clean Water Permit Requirements

1. We are aware that the Adams County Highway Department requires a permit for the construction of driveways and access roads located off of County Trunk Highways in Adams County.
2. We request that you please advise permit applicants that the discharge of dredged or fill material into wetlands and waterways for the construction of driveways or access roads may require a permit from the U.S. Army Corps of Engineers pursuant to Section 404 of the Clean Water Act. Other Federal, state, or local permits may also be required. This will help permit applicants avoid doing work that may be in violation of Federal law and could cause costly delays.
3. If you have any questions, or would like a determination whether a Department of the Army permit is required for a specific activity, please contact William M. Sande in our Stevens Point (Plover) office at (715) 345-7911. Requests may also be mailed to the U.S. Army Corps of Engineers, Regulatory Branch, 1314 Contractors Blvd., Plover, WI 54467.
