#1 thru #7

(See # inside triangle on bottom)

Rinse Clean & Dry

NO Motor Oil Containers &

NO Antifreeze Containers

unless empty and dry.



GLASS BOTTLES & JARS

Rinse Clean

Clear, Brown or Green Only

Not necessary to remove labels

Remove and discard caps & lids

NO Ceramics or Clay Pots

NO Light Bulbs

NO Dishes or Glassware

NO MIRRORS!

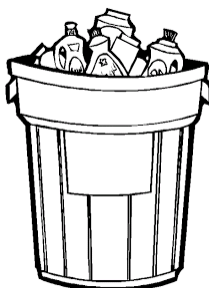
TIN/STEEL CANS

Rinse Clean

Paint Cans OK if Empty

Aerosol Cans OK if Empty

(Discard lid if not attached)



MIXED NEWSPAPER, MAGAZINES & JUNK MAIL

Bundle & Tie & put in your Recycling Container. Remember to tie with string, not wire.

YES Food, Beer, & Pop Cartons

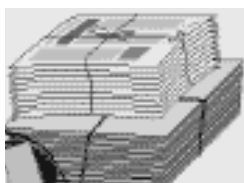
No waxed or contaminated by food.

ALUMINUM CANS

Rinse & Drain all Liquid

NO Foil

NO Pie Plates



CORRUGATED CARDBOARD

Place In or Next to Your Recycling Container.

Clean Corrugated Cardboard

Flatten Boxes & Keep Dry

Cut, Bundle & Tie into 3 Foot

Squares Pieces

NO Egg Cartons

NO Wax-Coated Cardboard

Not contaminated by food such as pizza boxes.

SUMMARY OF ADAMS COUNTY RECYCLING ORDINANCE #1-1994

Effective July 1, 1994 and subsequent years, persons can no longer throw the following *recyclable items in the trash or garbage, and MUST use a clear plastic bag (or see-through) for both garbage and recyclables. You must prepare recyclables according to the following specifications:

*ALUMINUM AND TIN CANS	MUST BE CLEAN, MAY FLATTEN, NO LID
*CARDBOARD-CORRUGATED	FLATTEN, NO WAXED OR CONTAMINATED w/ FOOD ie: PIZZA BOXES, CHICKEN/FISH
*CARTONS-CEREAL, SODA ETC	FLATTEN, NO WAXED OR CONTAMINATED w/ FOOD. PUT WITH PAPER, BUNDLED
*GLASS BOTTLES & JARS	MUST BE CLEAN, CAPS DISCARDED,
*MAGAZINES & GLOSSY	BUNDLE & TIE WITH STRING
*NEWSPAPER	BUNDLE & TIE WITH STRING
*OFFICE PAPER/JUNK MAIL	BUNDLE & TIE WITH STRING
*PLASTIC CONTAINERS #1 THRU #7	MUST BE CLEAN, CAPS DISCARDED
ANTIFREEZE	MAY BE TAKEN TO COUNTY LANDFILL
*APPLIANCES, MAJOR	MAY BE TAKEN TO COUNTY LANDFILL
BATTERIES, RECHARGEABLE	MAY BE TAKEN TO COUNTY LANDFILL
*BATTERIES (AUTO), LEAD ACID	MAY BE TAKEN TO COUNTY LANDFILL
*ELECTRONICS	MAY BE TAKEN TO COUNTY LANDFILL
*SCRAP METALS	MAY BE TAKEN TO COUNTY LANDFILL
*SHARPS	MAY BE TAKEN TO COUNTY LANDFILL
USED COOKING OIL	MAY BE TAKEN TO COUNTY LANDFILL
*WASTE OIL, FILTERS/ABSORBENTS	MAY BE TAKEN TO COUNTY LANDFILL
*WASTE TIRES	MAY BE TAKEN TO COUNTY LANDFILL
*YARD WASTE & BRUSH	MAY BE TAKEN TO COUNTY LANDFILL

No other material than listed above should be recycled. It costs a lot of money to remove reject material from good, clean recyclables. Contact the **Adams County Landfill & Recycling Center** for specific instructions and remember the rule - **WHEN IN DOUBT/THROW IT OUT!!!**

THE RECYCLING ORDINANCE STATES: All garbage placed at the curb, in our container, or taken to a drop-off location must be in CLEAR PLASTIC BAGS (will allow if see-through). This is to allow inspection of your bags. Any person who violates a provision of the Ordinance may be issued a citation. The hauler or drop-off site attendant has the RIGHT to reject, or leave at the curb, any solid waste for the following reasons:

GARBAGE NOT IN CLEAR PLASTIC BAGS (or SEE-THROUGH, up to \$5/bag violation fee)
RECYCLABLES MIXED WITH GARBAGE
DIRTY RECYCLABLES (ALL RECYCLABLES MUST BE CLEAN AND DRY)

ENFORCEMENT: The Adams County Solid Waste Department, any authorized officer, employee, or representative, including town officials and drop-off site attendants, has the RIGHT to inspect your recyclable materials to make sure they are prepared and sorted properly. They also have the RIGHT to inspect your trash to see if recyclables are not being separated. Any person who violates a provision of the Recycling Ordinance may be issued a citation.

NO PERSON MAY REFUSE ACCESS TO ANY AUTHORIZED REPRESENTATIVE WHO REQUESTS ACCESS FOR THE PURPOSE OF INSPECTIONS. NO PERSON MAY OBSTRUCT, HAMPER, OR INTERFERE WITH SUCH INSPECTIONS.
